ACT presented six productions as part of the Mainstage 2017 Season. Opening the season was "Tribes" by Nina Raine. This play was about a young Deaf man growing up in a hearing family and starred Deaf actor Josh Castille. "Tribes" opened ACT's doors to the Deaf community in Seattle and was the first show to offer the new Figaro MobiTxt Closed Captioning program to patrons. Second in the season was "Murder for Two," the co-production musical with the 5th Avenue Theatre, which ran 11 weeks to sold out houses. Running concurrently was the Matthew Lopez play, "The Legend of Georgia McBride," in which an Elvis impersonator turns drag queen in order to support his new family. The fourth production of the 52nd season was the world premiere of "Alex & Aris" by Moby Pomerance about the relationship

The 42nd annual production of "A Christmas Carol" surpassed its revenue goal at over \$850,000 and welcomed over 17,000 people into the theatre. All pre-show backstage tours were sold out, and this production continues to be a beloved holiday tradition for families in the Seattle area.

2017 was the ACTLab's 10th anniversary and ACT celebrated throughout the year with new and returning partners. It was a thrilling year for the Lab. Productions ranged from full-scale productions in our larger houses to small readings of new works in our intimate venues. The dance piece "Chitrangada" by well-known ACTLab partner Pratidhwani exceeded its goal by \$66,000. First time partner BenDeLaCreme surpassed their goal for "Beware the Terror of Gaylord Manor" by over \$50,000. Other diverse programming included productions from Theatre 22, Sandbox Radio LIVE!, the continuation of The Seagull Project's "The Great Soul of Russia," The Construction Zone project, "14/48: The World's Quickest Theater Festival," The Love Markets, Showtunes Theatre Company, and the Icicle Creek New Play Festival. ACT continues to invest in and develop its education programming. Managed by ACT's Artistic Engagement Manager, the Young Playwrights Program continues to bring teaching artists into area schools to instruct students in the art of writing a script. Over 400 plays are written each year and, from those, eight are selected to be performed in the Young Playwrights Festival in early spring.

ACT continues to invest in and develop its engagement events. From pre-show events with expert panel discussions to post-show dialogues with the casts or community responders, ACT's theatres are filled with patrons enriching their experiences at the shows and in the building. Nearly 50% of audiences attended post play discussions the run of "The Crucible." Each production included Behind-the-Scenes interviews, post-play discussion, cast chats, Tech Talks, and pre-show "dig deep" discussions about the themes in the plays.
